## Research and Publications

### Working Papers

– *Threshold-based-exemption in environmental regulation and firms dynamics (JMP)*

I study the long-run effects of a threshold-based exemption in a carbon tax where firms with emissions below a certain threshold are excluded. I use an industry dynamic model featuring heterogeneous firms and a carbon tax to show that removing the exemption leads to 1.9% output gain due to resource reallocation toward productive firms.

– *Emission offset provision in environmental regulation and firm's size distribution*

What are the macroeconomics implications of using offset credits for regulatory compliance? As a perfect substitute to regular permits, OCs prices are privately negotiated and may lead a relative lower price in line with firms bargaining power. I document that 15-20% of firms comply with OCs, and there's a positive relationship between the share of firms and emission complying with OCs and firm size. Using a general equilibrium model of industry dynamics with heterogeneous firms, I show that allowing OCs as an option of compliance can be welfare enhancing if properly enforced with a TFP gain of 0.10%.
